Zoning Administrator's report

The Zoning Administrator expressed that the Planning Commission should strive to keep in mind the real purpose of us being here is to help the homeowner, determine what appropriate accessory uses for properties are, protect the environment, and protect the abutter. Deb motions to remove "s" on reports from contract and that the information is submitted to WRC by the planning commission chair in Tasks 2 and 3 of Scope of Work. Steve Seconds. Bill amends to include "and other available information," Cindy seconds, Amendment passed. Motion passed.

Review timeline for completing amendments by grant deadline

Sam passed out a draft schedule for completion of zoning map, zoning bylaws, corridors, and Municipal Planning Grant to be completed by May 2014. General consensus was that this is a tight timeframe, but certainly workable
