# **Article II Zoning Districts and Map**

Sections 205-240: Zoning districts are revised to be compatible with the Land Use section of the Town Plan and the Town Plan Future Land Use Map.

- Zoning districts removed: Forest Reserve; Reserve;
- Zoning districts added: Productive Lands; Rural; Residential
- The Village district is revised and renamed Settlement Areas.
- Zoning Map is revised with new districts and boundaries.
- The Allowed Uses and Conditional Uses for each district are revised.
- Uses removed: Camp, Conservation, Public Utility, Greenhouse/Nursery, Dumpster
- Uses added: Agritourism; Gasoline Service Station; Licensed Childcare Facility; Neighborhood Store; Residential Care Facility; Solid Waste Facility; Storage Facility
- Setbacks are not altered except in the Settlement Areas district, where they are reduced.
- Minimum Lot Area is revised in many parts of town, depending on the change in district.

Section 241: Descriptive language describing map removed.

- The terms "Resource Area" and "Shoreland Area" are both changed to "Riparian Area" throughout the article.
- The setback requirement for sewage is removed as that is now regulated by the state.
