The purpose of the Amendment is to adopt the state regulated speed zones on State Highway Route 5 and State Highway Route 30 in the Town of Dummerston, Vermont, pursuant to Vermont Statutes Annotated Title 23, Section 1007(a)(2) to allow the Town of Dummerston to collect a percentage of the funds collected by the State for speeding violations that occur on State Highway Route 5 and State Highway Route 30 in the Town of Dummerston, Vermont.

The Amendment to the Town of Dummerston Traffic Ordinance is to Article 4, Speeding Restrictions.

Notice is hereby given that citizens have the right to petition the Selectboard for a permissive referendum vote on the ordinance at an annual or special meeting as provided for in 24 V.S.A. § 1973. Such petition for a permissive referendum must be signed by not less than five (5) percent of the qualified voters of the Town of Dummerston and shall be presented to the Selectboard or the Town Clerk within forty four (44) days following the date of adoption. Unless a petition is filed in accordance with 24 V.S.A. § 1973, the Ordinance shall become effective sixty (60) days after its adoption. (July 14, 2003)


