

## **Dummerston Energy Committee Draft Minutes**

**Monday, November 7, 2016 6 pm**

**Dummerston Community Center**

**Meeting came to order at 6:05pm, in attendance were Alex Wilson, Stanley Howe, Will Collins and Julien Geiser**

1. Review agenda, add items as needed

2. Approve minutes from October 3, 2016 meeting

- Will moved to approve the minutes from the October 3<sup>rd</sup> meeting, Stanley seconded the motion. All members were in favor of approving the minutes.

3. Continued discussion of potential solar system on the capped WSWMD landfill

Potential contract with the Town

- Julien moved to recommend to both the Town School Board and Selectboard that they move forward with contracts that would allow them to participate in the capped WSWMD solar landfill project and that the DEC would remain available to them for consultation. Will seconded the motion. Discussion: Stanley pointed out that the Town spends approximately \$50,000 a year on energy and that they would save around \$1,000 a year by signing up for this program, or about 2% of the annual energy use. All members were in favor of the motion.

4. Discussion of WRC grants program

Funds from the Clean Energy Development Fund

- Will moved that the DEC approach the Town School Board, inform them of the CEDF and encourage them to consider applying for the grant to help offset the cost of the School's wood boiler project. All members of the DEC were in favor of the motion.

No discussion but Will had for action to send the grant details to Dan Normandeau for review by the Town School Board.

- Alex proposed that we send off the grant information to other possible businesses in town, including Allard's Lumber and Hermit Thrush Brewery, and had that item for action.

## 5. Work session on Energy Chapter of Town Plan

Discussion of specific goals:

- The DEC reviewed the two existing goals and associated policies/actions and added a third goal aimed at encouraging the purchase of fully electric or hybrid vehicles by Town residents.
