Called to order at 5:32PM

- Introduction, background of the groups process over the past few months.
- L.H. updated groups on departure of Dena Marger from library.
- J.W. talked about the brainstorming of an ad-hoc group of residents and read a “2030 Vision” statement that she and A.W. had about what the library could be like in the year 2030 as a meeting place for town residents, resilience hub, event space, etc. J.W. read the groups expanded proposal for the merger and ideas of how committees within the Dummerston Community Center & Library would cover different responsibilities.
- R. Turner discussed talk with Friends of Lydia for providing a home for View of Dummerston as the Dummerston Community Center board no longer has non-profit status.
- Discussion ensued about fundraising and applying for grants.
- P.Adkins mentioned the original goal of the Community Center to offer more educational programs (such as music lessons) than what came to fruition. Others mentioned possibilities such as Tai Chi.
- T.N. asked if 5 trustees would be able to handle the new responsibilities or if 7 would be better. G.S. and L.H. voiced a preference for 7. R. Hickin voiced support for 8 trustees and mentioned that Selectboard could appoint new trustees in interim before Town Meeting 2027.
- **At 6:26PM the Dummerston Planning Commission took over the Zoom account and the Zoom portion of the meeting ended.**
- A discussion ensued about the parameters and logistics needed for an article at Town Meeting.
- R. Hoffman suggested a brief article, with a write-up of more in-depth details to be included in the printed town report so voters could be informed prior to the vote.

- J.W. summarized what is being proposed: A name change to Dummerston Community Center & Library and direction from town to give responsibility of building to the trustees. The trustees would also be allowed to expand to 7 members. This proposal was approved by the general consensus of those in attendance, though no official vote was held.
- G.S. asked what the immediate plans are for the library. L.H. replied that it is T.B.A. and that a posting for a new librarian is to come.
