Hearing on Amendment to the current Traffic Ordinance:

The Selectboard held a public hearing and proposed the adoption of an amendment to the current Traffic Ordinance. The purpose of the Amendment is to adopt the state regulated speed zones on State Highway Route 5 and State Highway Route 30 in the Town of Dummerston Vermont, pursuant to Vermont Statutes Annotated Title 23, Section 1007 (a) (2) to allow the Town of Dummerston to collect a percentage of the funds collected by the State for speeding violations that occur on State Highway Route 5 and State Highway Route 30 in the Town of Dummerston, Vermont. The Amendment to the Town of Dummerston Traffic Ordinance is to Article 4, Speeding Restrictions. A motion was made and passed unanimously to adopt the Amendment to the current Traffic Ordinance.

Wayne discussed information for road stabilization and dust control; he will attend a seminar about this. The highway department has been screening sand and will be crushing stone next week. The covered bridge has been swept and washed; other bridges have also been cleaned. The generator from Emergency Management has arrived at the Town Garage-a cement pad needs to be poured to set the generator on. The annual road tour of town roads will probably be done in June. There will be a pre-bid meeting for the Camp Arden Road project at the site on May 28<sup>th</sup> at 2:30 PM.

No bid has been received for roadside mowing.

Truck bids were opened for the replacement of two truck bodies with one side dump body with tarping system and three additional Pioneer EDD tarping systems to be mounted on three other Town of Dummerston Mack trucks. Bids are to be with trade and without trade. Two bodies will be traded in.
