I. CALL TO ORDER

Chairperson Zeke Goodband called the meeting to order at 6:00PM. All Board members present.

II. **REVIEW & APPROVE MINUTES OF PREVIOUS MEETING** –May 29 Lewis moved, Steve seconded minutes were approved.

III. REVIEW & APPROVE BILLS FOR PAYMENT – 25, 25P, CC6, EC5

VI. RECOGNITION OF VISITORS & PUBLIC COMMENTS

Pam McFadden reported the town's electric bill has not been reduced by the elimination of lights in Dummerston Center. GMP stated the town still pays for the lights until they are removed.

VII. RENAUD GRAVEL PIT UPDATE

Steve thanked Treasurer, Laurie Frechette, for her work with the Town of Putney in smoothing the opening of the Renaud Gravel Pit. Steve reported that the access road is well under way and "significant" progress is being made.

VII. CORRESPONDENCE – FOR INFORMATION

Pam McFadden reported on confusion over late filing and penalties. New legislation has caused confusion. Joe moved to NOT assess penalties for this year for failure to file homestead declaration. Steve seconded the motion. Passed 5-0
