His plan is to have an energy efficient, sustainable brewery/distiller, vineyard and eventually reopen for skiing. Part of his plan is to grow corn, wheat, and barley on the property for the brewery and bring back an old apple orchard as well. The tentative plan is 1-2 years open the brewery & distiller, 3-5 years open the vineyard, and 8-10 years reopen the ski area.

The Town of Dummerston, by and though its Selectboard, and pursuant to 24 VSA Section 1007(a)(2) adopts the State of Vermont speed limits on State Highway Route 5 and State Highway Route 30, listed within Vermont Statutes Annotated Title 23, as the local speed limits within the Town of Dummerston.

**ARTICLE 9. EFFECTIVE DATE.** This ordinance shall become effective 60 days after its adoption by the Town of Dummerston Selectboard. If a petition is filed under 24 V.S.A. § 1973, that statute shall govern the taking effect of this ordinance.
