On a motion by Terry and second from Maria the Board voted 4-0 to sign the FY 23 Grant In Aid agreement.

The crew has been working on roadside mowing, grading, and culverts. Lee has been working with Charlotte to get the hydraulic information uploaded to the State database.

Roger Jasaitis, Zoning Administrator, sent the Board a draft welcome letter he is planning on sending to any new property owners. This will help new owners that may have questions regarding zoning. It was the consensus of the Board that it was a good idea for Roger to send the letter out.

On a motion by Terry and second from David the Board voted 4-0 to sign the Errors and Omissions Statements as presented by the Listers.

ARPA Updates & Discussion – The Town should be receiving the next check this week. Terry will be conference calling with Katie Buckley from VLCT regarding procedural questions. The Historical Society will be getting estimates for mini-splits. On the next agenda for consideration will be requests from the Recreation Board and Historical Society.
