The new truck has gone to Viking for the body installation. He will try to sell the old truck.

The Town received approval for the 2023 Grant In Aid. The projects include areas on Dutton Farm Road, Kipling Road, and Black Mountain Road.

The crew has also been working on grading, making sand for next year, and has fluid filmed trucks.
