On a motion by Paul and second from Todd the Board voted 4-0 with Skip abstaining to approve the minutes from March 19, 2025.

On a motion by Todd and second from Maria the Board voted 5-0 to approve the minutes from March 26, 2025 Special Meeting.

On a motion by Todd and second from Maria the Board voted 5-0 to approve payment of warrants 20 & 20P.

## **Road Foreman's Report:**

The following Ford F550 truck bids were received and opened on February 19th:

Faith Ford \$70,289.00 Ford of Claremont \$70,155.00

The Board tabled awarding this bid until further discussion with Lee. The amount approved at Town Meeting for the truck was \$100,000. The above bids did not included the truck body or plow.

The Board and Lee discussed the following updated pricing:

Cab & Chasse 70,289.00
Dump Body 56,950.00
Plow 8,200.00
Total 135,439.00

Lee is hoping to get \$35,000 from the sale of the 2017 Dodge. The Board discussed what the delivery timeline and options to request additional funds to cover the money over the Town Meeting approved amount of \$100,000.

On a motion by Todd and second from Tom the Board voted 5-0 to set a Special Town Meeting to ask for additional funds of \$36,000. The Board is hoping to have the special meeting at 6 pm on 4/30 with the regular meeting to follow. The location will be determined, either the Grange

or the Community Center. Lee will confirm pricing. Maria will reach out to Laurie to see what requirements need to be met to have a special town meeting.

On a motion by Todd and second from Paul the Board voted 5-0 to approve and sign the VTrans Financial Plan & Certificate of Compliance - Road Standard Form.

The Board discussed with Lee – Road Foreman and Eliza Greenhoe-Bergh the maintenance of Greenhoe Road near Bill Bandish's property. Bill has been plowing this section of road to get to his driveway. This portion of Greenhoe Road is Class 4. The town does not maintain class 4 roads. Bill would like to cut trees along the road and at the bottom near the Town turnaround. Lee is fine with the turnaround as is. Bill can cut trees and brush on his property, but must get permission from neighboring property owners to cut elsewhere along the road. The Board also discussed the possibility of needing Bill to sign a liability waiver for plowing a Town class 4 road. Todd will send Bill a response.
