On a motion by Tom and second from Todd the Board voted 4-0 to approve the minutes from September 17, 2025.

Road Foreman's Report:

Lee reported that the check valve in the well at the highway garage will need to be replaced. New Employee, Parker Waite, passed his CDL exam.

The Town received \$20,000.00 from the Better Back Road Grant for Stickney Brook Road project.

Paperwork has been submitted for the Grant In Aid.

Warrant #7 included ARPA funds paid for structures engineering.

The blasting will take place once the fund expenditure is approved at a special town meeting.

New Business:

Town fill dirt policy/fees – The Board voted at the 9/17 meeting to eliminate the permit and fee for ditching the roadsides and dumping the dirt at residences in Town. The Zoning Administrator asked the Board to reconsider this motion.

Todd made a motion to eliminate the fee, but not the permit, Tom seconded. Maria pointed out that a listed exemption in the zoning bylaws was the grading and excavation associated with road and driveway maintenance and lawn and yard maintenance. After discussing the consensus was to let the approved motion from 9/17 stand. The above motion by Todd was withdrawn. Todd will ask Roger to compile a list of who completed permits and paid the fees for roadside ditching or having the dirt dumped on their property for the last five years. At the next meeting the Board will discuss refunding these fees.

On a motion by Todd and second from Skip the Board voted 4-0 to approve the warning to set Wednesday, November 5, 2025 at 6:00 pm for a Special Town Meeting to approve Blasting & Ledge Crushing Expenditures. This will not affect property taxes, as the funds are already in the fund, this is just authorizing the expenditure.

On a motion by Maria and second from Todd the Board voted 4-0 to approve the Special Event Permit for an event at the KOA Campground on 10/18/25, 3-8 pm.

On a motion by Maria and second from Todd the Board voted 4-0 to adjourn as the Liquor Control Board and reconvene the meeting at 6:26 pm.
