Site visits were completed prior to hearings.

Hearing for application #3583 from Caleb Lewis for Conditional Use for an accessory dwelling located at 31 Clay Pit Road began at 6:44. Caleb has had a tiny house located on his aunt's property for approximately 12 months. He is not there full time at this point, mostly weekends as he works out of town for the summer. He is not quite 100% self contained. He has a composting toilet and a gray water tank is on the way. He uses his aunts electricity and there is ample parking. He is looking into solar power, does not use a generator. Roger read the state definition for a structure and Caleb falls into that category so needs to acquire a permit for gray water and tank from the state if his tiny house is not on wheels and moveable at any given moment. Roger stated that DRB can give a permit but it will not be considered valid until state permit is received. Caleb intends to leave the area soon but wants the option to come back if it doesn't work out. The permit would be valid for 2 years. Closed hearing at 7:04.

Hearing for application #3585 opened at 7:05. Green Mtn. Conservancy is looking to acquire a Conditional Use permit for a parking lot at their trail head on Camp Arden Road as well as approval for a sign located on site. Sam Farwell reported for GMC that they purchased with the help of the state 297 acres to be used for public access for hunting, fishing, hiking etc. They would like to be able to
