I did take notes on what people said once the meeting became more of a public hearing. For the minutes however, after talking it over with Laurie Frechette yesterday, I am probably going to say that a general discussion took place with many people making comments; I may list some of the comments to give a sense of the range of opinion. Minutes should not be a transcript of a meeting. If you look at the selectboard minutes from the recent public hearings on the town plan you will see that they are not transcriptions of those meetings. That said, I will send you, separate from the minutes, a list of who spoke and the bullet points of what they said. For example: Paul Normandeau; urged Committee members to find a balance, does not want to see Rt5 become a Brattleboro North. Cliff Allard; suggested buying development rights rather than changing zoning districts for preservation purposes. Randy Khan; suggested tapering development from the Brattleboro town line on northward. Will that approach work for this Committee? Also I would ask that your Committee ask members of the public to submit in writing any proposals or comments that go into specific detail or are more complex than can be accurately noted in a bullet type format.

It would also be helpful for someone to record on a flip chart the ideas that people express so they can "see" what's been said. That often helps them add or expand on ideas and it can also save time if people don't repeat ideas that are already recorded. I'd be happy to arrange for the flip chart and do the recording on it at the meeting. Last, it would also be helpful if we could help focus public input by asking them to respond to 3 or 4 specific questions as discussion starters. For example, we could ask them "What concerns do you have for the future of your land?", or "What do you like most (or least) about the current land use along the road?"

If you want our next meetings to be like the one last night, gathering public input, we really need to make sure the Agenda says that, and that it's warned as a public hearing, not just a committee discussion. We spent a majority of last night listening to the public (a good thing) and very little time discussing among committee members land use issues in the southern portion of the corridor. Given the sensitivity that came up during the town plan process about keeping the public Informed, we need to be extra careful about agenda details.

Steve.

Some thoughts on Tuesday evening's meeting. With the change of location to the Learning Collaborative, I anticipated some additional people would be present but I didn't know you had a full blown neighborhood meeting in mind. I had thought we'd have a regular committee meeting in prep for a neighborhood meeting on the last Tuesday evening of the month, a procedure it seemed we had agreed upon.

Those present did indeed express their development interests but for me what was said by and large was a repeat of what they and others said at the Planning Commission and Selectboard meetings and hearing on the Town Plan. Not having anything specific to respond to beyond "factors regarding development in the corridor", there was only limited talk about development limitations and the kind of development that would be desirable, and where. We got into the subject of land use districting for only a small part of the corridor.

In looking to upcoming meetings, my suggestion is that we have regular committee meetings on the first tuesday in prep for neighborhood meetings on the last tuesday. At committee meetings we can talk among ourselves (for the most part) about development limitations and potentials for the section of the corridor that will be the subject of the next neighborhood meeting. The latest WRC maps are a good place to start in this regard. We can also share with one another our thoughts on the rural commercial designation in the present town plan, and whether any other districting possibilities for the corridor in question are worth considering. This prep would provide us with both information and questions to present and consider with those who come to the neighborhood meetings.

Two meetings a month for the committee may be more than some want but I think we'd be doing everyone a service with them. The neighborhood meetings for their part would be more focused and useful and the committee would have opportunity to get itself better prepared and organized to decide its recommendations for corridor districting and densities
