

SELECTBOARD MEETING                      MARCH 3, 2004

This meeting was called to order at 7:30 PM at the Town Office in Dummerston Center, Vermont.

Organization of the Selectboard: A motion was made and passed to keep the same officers as last year: Paul Normandeau, Chairman; Shorty Forrett, Vice-Chairman; Lester Dunklee, Clerk.

Members Present: Shorty Forrett, Vice-Chairman; Lester Dunklee, Clerk, Cindy Jerome and Jack Manix.

Also Present: Road Foreman Wayne Emery, Beverly Knapp.

A motion was made and passed to approve the minutes of February 18, 2004 and to pay Warrants 18 & 18P.

Wayne: the highway department has been pushing back snow banks and cutting brush. Wayne has been speaking with Floyd Roberts at the Agency of Transportation, District 2-Dummerston has been underfunded on the highway program and Mr. Roberts suggested that the Town submit a grant for \$150,000 for retreatment. This would enable the Town to focus on Middle and Bunker Roads and East-West Road starting at the bridge and coming towards the center. A grant application needs to be done every year. Wayne spoke to the Board regarding trees being kept high enough for truck traffic use on the roads. The Board agreed with Wayne to have Charlie Richardson review this. Cindy gave Wayne a copy of a "Snow and Ice" policy that Hank Lambert (Vermont Local Roads) had mentioned.

The Town has received several complaints on barking dog(s) owned by Richard Jacques and Kim Kim Cretelle on Hague Road. The Sheriff's Department has been there several times and have now issued a "Notice of Violation of Dummerston Animal Nuisance Control Ordinance." The Board put the matter on hold until Paul Normandeau, Chairman, returns.

A motion was made and passed to appoint the Brattleboro Reformer and Town Crier as Dummerston's official newspapers. The Board made various Town appointments-please see attached listing.

The Dummerston Selectboard recessed at 8:30 PM; the Dummerston Liquor Commission was called to order at 8:31 PM.

A motion was made and passed to sign the Second Class Liquor License for MKF., d/b/a Mike & Terry's Exit #4 Store. A motion was made to sign the Tobacco License for MKF.-VOTE: Yes-Shorty, Jack and Lester. NO-Cindy. Motion passed. The Dummerston Liquor Commission adjourned at 8:35 PM.

The Dummerston Selectboard meeting reconvened at 8:36 PM. A motion was made and passed to enter into executive session at 8:40 PM to discuss real estate and personnel matters. Executive session adjourned at 9 PM. No decision was made.
